Technical bid in Envelope - ðAö Shall be submitted in the prescribed performa as enclosed in the tender form and shall be opened on the same day at **1200 hrs.** Whereas, financial bid in Envelope - ðBö is to be submitted in the performa containing schedule of work / quantities.
2. All the material shall be arranged by the contractor and quality shall be got approved, from the officer authorized to do so, before starting the work.
3. Substandard material and workmanship will be rejected without any compensation. No claim for loss or damage thereof shall be entertained.
4. In case the work is left over or abandoned at any stage, whatsoever the reasons may be, the remaining work shall be got completed at the risk and cost of the defaulting contractor, either departmentally or through other contractor / source and the excess amount spent by the department in getting such work completed will be to the account of original contractor and shall be met from any amount due to him or recovered by normal legal channel.
5. Contractor is fully responsible for disposal of malba and silt from the site / complex.
6. No T & P shall be issued by the department.
7. During execution of work if any damage to the existing structure / Buildings, occurs at site, the contractor shall have to restore it at his own risk and cost.
8. In case of any mishappening at the site of work the problem will have to be tackled and the contractor shall be fully responsible.
9. In case, any contractor submits a false certificate / document, the EMD shall be forfeited without any notice.
10. The contractors should inspect the site before submitting their offer/rates.
11. The successful tenderers shall be the sole and principal employer of all the staff and labour employed by them shall be responsible for observing and complying with all employment regulations, labour laws and other laws as applicable and as laid down in this behalf from time to time in respect of all the employees of the tenderer.
12. No Sub-letting of the work is allowed.
13. No claim for any fluctuations in rates or otherwise will be entertained
14. The work shall be executed and accepted strictly according to the CPWD specifications with all the amendments and correction slips up-to-date.
15. The successful tender shall be deposit security money 10% within 05 days from the date of allotment letter and shall be released after six month of satisfactory completion of work report.
16. The Executive Director (A), SAI NS NIS, Patiala reserves the right to reject all the tenders without assigning any reason.
