TERMS AND CONDITIONS

- Netaji Subhas National Institute of Sports is a National Institute providing Academic programme and training of sports persons. On an average there are about 300 to 400 trainees in the Institute. It has six Hostels at present. It has office buildings, Guest Houses etc., apart from Hostels. The linen items/curtains are to be washed/dry cleaned/ironed on periodic interval as per requisition of the Competent Authority.
- 2. The Bidders are required to mention rates against each items <u>for Hand washed washing & ironing both, only washing & only ironing and Dry cleaning etc. as mentioned in Financial Bids, (Annexure-II). The rates shall be operative during the period <u>w.e.f. the dates from issue of award letter</u>. The contract can be extended for further period of one year on same rates, terms & conditions subject to satisfactory laundry services provided by the contractor during the contract period.</u>
- 3. The rates approved shall also be applicable for the above facility to be provided to the trainees. However, trainees will make payment on the said approved rates directly and Institute will not be responsible.
- 4. The Institute will provide water on payment basis. <u>The lumps sum amount of Rs.1000/- per month for the supply of water shall be charged from the contractor</u> and space for laundry shall be provided by the Institute on free of charge. The contractor will have to pay the water charges on or <u>before every 10th day of month.</u>
- 5 The Institute will provide electricity connection with a Sub Meter and the <u>Contractor will have</u> to pay electricity charges on or before every 10th day of month as per meter reading at the rate Institute is paying electricity charges to PSPCL (Per Unit).
- 6 Earnest money of Rs. 5,000/- (Rupees Five thousand only) through crossed demand draft drawn on any commercial bank in favour of Sr. E.D (A), SAI NSNIS, Patiala should be submitted on or before 02-03-2022 and sent to Deputy Director(GAD), SAI, NSNIS, Patiala.
- 7 The Sr. Executive Director (A), SAI NS NIS, Patiala will have the right to forfeit the EMD/Security deposit, if the terms & conditions of the Agreement are not adhered to by the bidder.

- 13 The rates so approved by the Institute will also be applicable for the Institute's employee residing inside the Campus as well as for the trainees/campers, but they will have to be charged directly by the successful Contractor and no responsibility/liability of Institute arises in this respect.
- 14 The Contractor would be required to use good quality of Petrol, Powder & detergent etc., for washing/dry cleaning. All kinds of clothes should be washed neat and clean.

- 15 The Contractor will keep the area allotted clean and hygienic at all times.
- 16 There will be no increase in the rates of washing/dry cleaning, ironing charges etc., till the expiry of the contract.
- 17 The Contractor shall not sublet the laundry in any manner whatsoever.
- 18 The Contractor will not do the laundry work of the outsiders in any manner. If found, the contract will be treated as cancelled immediately and security shall be forfeited.
- 19 The services of the Contractor, if not found satisfactory, will be terminated without assigning any reason by giving a notice of 30 days.
- 20 The taxes/levies, as prescribed by the Govt. of India/State Govt. for such contract shall also be levied as per the concerned Act and it will be borne/paid by the Contractor.
- 21 The dispute if any, the courts in Patiala alone will have jurisdiction in respect of all legal proceedings connected therewith.
