2. **Earnest money of Rs.30000/- (Rupees Thirty thousand only)** OR 3% of the estimated value of the quoted item(s) will have to be attached in the form of bank draft/ bankers' cheque, FDR or Bank Guarantee payable at Patiala drawn in favour of **Sr. Executive Director(A), SAI NS NIS, Patiala** along with the **Technical Bid in Envelope 'A'**.
3. The **Financial bid** be submitted in **Envelope 'B'**
4. Both the bids should be submitted in an envelope on which the words "**Tender for the supply of stitched blazer & neck tie**" should be super scribed on the top of the left corner of the envelope which should also show the name and address of the bidder.
5. Sample of stitched blazer & neck tie should be submitted in the office of Deputy Director (Stores), SAI NS NIS Patiala.
6. Successful bidder shall execute an **agreement** for the due performance of this contract on non-judicial stamp paper worth **Rs.50/- within 10 days** of the receipt of the supply order.
7. Successful bidder shall have to deposit an **performance security money @3% of the total value of the contract** within 10 days of the receipt of the supply order which will be refunded on the expiry of the contract
8. The interested parties may give their competitive rates inclusive of taxes **F.O.R., SAI, NIS, Patiala** quoted in tender.
9. The Sr. Executive Director will have the right to reject any or all the bids without assigning any reason.
10. Bids received without Samples of quoted items, conditional or incomplete having cuttings or overwriting is liable to be rejected.
11. The supplies received, if not found as per approved sample of tendered items, are liable to be rejected.
12. In case the bidder fails in making the supply in a given time and place the Institute shall have the right to purchase the same from the other source at the risk and cost of supplier.
13. The contract can be terminated or cancelled summarily by SAI in whole or in part any time without assigning any reason, if the supply made by the manufacturer/ supplier is not found according to the sample approved or in case supply is not received within stipulated time
14. In case any dispute arises in regard to the tender, the decision of the Sr. Executive Director, SAI NS NIS, Patiala will be final and binding.
15. In case of litigation, the courts at Patiala only will have jurisdiction for deciding case according to Indian law in force.
16. The technical bid of the bidders will be opened first and the financial bid will be opened only of the bidders whose Technical bid shall be accepted by the competent authority.
