Provisional Merit list-2 for Diploma Course in Sports Coaching 2026-27

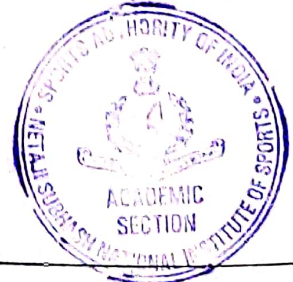

JOINING INSTRUCTIONS TO THE CANDIDATES

Candidates provisionally selected for the admission to Diploma Course in Sports Coaching session 2026-27 are advised to read the following instructions carefully and act accordingly:

- Admission of the candidates is subject to verification of certificates in respect of educational qualifications, sports achievements, physical and medical fitness.
- The candidates need to report at their respective centre for **Medical Test as per the schedule** mentioned in **Annexure-V**. Only those candidates who are declared medically fit will be eligible for final admission to the Diploma Course. In case any candidate is declared medically unfit, his/her provisional admission shall stand cancelled, the name shall be omitted from the final selection list.
- If, at any stage, a candidate is found ineligible under the Admission Notification dated 27.03.2026, has submitted false, fake, or forged documents, or is found physically or medically unfit, his/her admission shall be cancelled, even if such discrepancy is detected after admission, during the course, or after completion of the course.
- For the Athletics, Hockey, and Volleyball disciplines, the training centre shall be allotted based on the candidate's merit and the order of preference indicated in the application. If no preference is exercised, the centre shall be allotted strictly in the order of merit, with preference being assigned sequentially to SAI NS NIS Patiala, SAI NSSC Bengaluru, and SAI NSEC Kolkata.
- Candidates must deposit the prescribed admission fee during the **fee payment window from 21st July 2026 to 23rd July 2026 (up to 11:59 PM)**. Candidates failing to do so within the stipulated period shall forfeit their claim for admission, and their seats shall be offered to candidates from the reserve/waiting list strictly in order of merit.

Mandatory Documents to be Produced at the Time of Reporting at the Allotted Training Centre

All provisionally selected candidates shall report to their allotted training centre with the following documents:

1. Original certificates/documents relating to educational qualifications and sports achievements, along with two sets of self-attested photocopies.
2. Printed copy of the submitted Application Form.
3. Admission Fee Receipt and Boarding & Lodging Fee Receipt.
4. A duly signed Undertaking in the prescribed format enclosed as Annexure-III.

5. No Objection Certificate (NOC) from the employer, in case the candidate is employed in any Department/Organisation. Non-Submission leads to disqualification from the course.
6. A valid Mediclaim/Health Insurance Policy with a minimum validity of one year, covering injuries and health-related expenses.
7. Candidates awaiting the final result of their qualifying examination shall submit the Provisional Degree/Certificate on or before 25.07.2026.

Failure to produce the requisite documents or fulfil the above requirements shall result in cancellation of the provisional admission.

3. If a student chooses to withdraw from the Diploma Course in Sports Coaching in which he/she is enrolled, the institute will follow the refund policy of University Grants Commission (UGC) 2018 with approval of Academic Council of SAI NSNIS, Patiala.
4. Sports Authority of India reserves the right to cancel the course, change venue of course in view of inadequate response or due to other administrative reasons without any notice.
5. The candidature shall be summarily rejected in cases of misrepresentation, fraud, or a NADA report confirming doping violations, as well as in instances where relevant information has been knowingly or unknowingly concealed to secure admission to the institute
6. Any act inviting the disciplinary action against the doer, will be sufficient for suspension/termination of the trainee/doer immediately.
7. Any act inviting criminal proceedings against the doer/trainee will be debarred from the course with immediate effect.

8. Non-disclosure of the pending criminal cases by trainee (being any party to the case) will be liable to be debarred from the course.

UNDERTAKING

I, _____, Son/Daughter of _____, having being provisionally selected for admission to the Diploma in Sports Coaching in the discipline of _____ for the academic session 2026–27, to be conducted at SAI NSNIS, Patiala / SAI NSSC, Bengaluru / SAI NSEC, Kolkata / SAI LNCPE, Thiruvananthapuram, do hereby solemnly affirm, undertake and declare as under:

1. That all documents, certificates and information submitted by me in support of my candidature for admission to the Diploma in Sports Coaching Programme are genuine, valid and authentic. In the event that any document or information furnished by me is found to be false, forged, fabricated, incorrect or misleading at any stage in that event my candidature, admission, selection or award of Diploma shall be liable to be cancelled forthwith without any prior notice and I shall have no claim whatsoever against the SAI and its institution arising out of such cancellation, withdrawal or action taken thereon.
2. That I have not been convicted of any criminal offence by any court of law and that no criminal case, investigation, inquiry or criminal proceeding is pending against me before any court, tribunal or competent authority as on the date of this undertaking. I further declare that I have never been involved in, prosecuted for or tried of any criminal offence in the past.
3. That during the period of the course, I shall maintain good conduct and discipline and shall not indulge in any act, omission or activity that may constitute a violation of law or attract criminal investigation or proceedings or bring disrepute to the Institute, its officials, coaches, staff members or fellow trainees.
4. That if I am found to be in violation of any rule, regulation, term or condition governing the Diploma Course or if any disciplinary proceedings are initiated against me on account of misconduct, indiscipline or any act unbecoming of a trainee then in that scenario I shall abide by and accept the decision of the Institute which may include but not limited to a warning, suspension, debarment, expulsion or cancellation of my admission.
5. That I shall strictly adhere to the rules, regulations, dress code, discipline, code of conduct and instructions issued by the Institute from time to time, and shall maintain decent behaviour and decorum befitting an Institute of national importance.
6. That I undertake to carry my identity card at all times while on the Institute campus and shall produce the same upon demand by any competent authority or duly authorized security personnel for verification and identification purposes.
7. That I shall conduct myself in a courteous and respectful manner towards all fellow trainees, coaches, faculty members, officials, staff and other authorities of the Institute and shall uphold the dignity and decorum of the Institute at all times.
8. That I shall neither directly nor indirectly influence or attempt to influence any trainee, coach, faculty member, official or staff member of the Institute with a view to securing any undue benefit, favour, concession or advantage for myself or any other person during the tenure of the course or thereafter.

9. That I shall diligently participate in all academic, practical, training and institutional activities of the Institute and shall at all times act in a manner that upholds and promotes the dignity, discipline, development and reputation of the Institute and the sports fraternity.
10. That I shall faithfully abide by and comply with all decisions, directions, orders, rules, regulations, guidelines, policies and instructions issued by the Institute or any Competent Authority from time to time during the tenure of the course. I further undertake to observe and implement the same in letter and spirit and acknowledge that any violation thereof may render me liable to such disciplinary or administrative action as may be deemed appropriate by the Institute.
11. That I shall maintain the requisite level of physical fitness throughout the duration of the course and shall participate in all prescribed physical training, practical sessions and physical fitness tests. I further understand and acknowledge that failure to participate in, complete or qualify the prescribed physical fitness requirements or tests may render me liable for removal, discontinuation or debarment from the course in accordance with the applicable rules, regulations and decisions of the Institute.
12. That I fully understand the nature of the physical training involved in the course and acknowledge the inherent risks of injury, accident or physical strain associated with such training and related activities. I am joining and participating in the course voluntarily and at my own risk and I shall not hold the Institute responsible for any injury, loss or damage suffered by me during the course.
13. That in the event of any illness, injury or medical condition resulting in my absence from training, classes or other course-related activities for a continuous or cumulative period of fifteen (15) days or more then in that scenario my candidature/admission may be cancelled and any fee deposited by me may be forfeited.
14. That I am not involved in nor have I ever been found guilty of any offence relating to doping, and I have not been debarred, suspended or otherwise disqualified from participation in any sporting activity by any Competent Authority, Anti-Doping Organisation, sports federation, association or regulatory body. I further undertake to comply with all applicable anti-doping rules and regulations during the tenure of the course.
15. That I shall exercise due care in the use of all buildings, infrastructure, sports equipment, training facilities, hostels, libraries, vehicles and other property belonging to the Institute. In the event of any loss or damage caused to such property due to my negligence, misconduct or wilful act then I shall be liable to compensate the Institute for the loss suffered, without prejudice to any disciplinary action that may be taken against me.
16. That I shall not consume, possess, distribute or be under the influence of any narcotic drug, psychotropic substance, intoxicant, prohibited substance, alcohol, tobacco product or any other substance prohibited by law or by the rules of the Institute within the campus or during any activity connected with the course. Any violation thereof shall render me liable to disciplinary action including suspension, debarment or expulsion from the course.
17. That I shall neither engage in nor abet, encourage, facilitate or participate in any form of ragging, harassment, bullying, intimidation, discrimination or any act detrimental to the dignity of another trainee. I understand that any act amounting to ragging shall invite strict disciplinary and legal action in accordance with applicable laws and regulations.
18. That I shall strictly comply with all hostel rules, regulations, timings, security protocols and instructions issued by the Institute from time to time. I understand that any violation thereof may result in withdrawal of hostel facilities in addition to any disciplinary action that may be deemed appropriate.

19. That I shall maintain the minimum attendance prescribed by the Institute in academic classes, practical sessions, field training, physical training, internship and all other course-related activities. I understand that failure to maintain the prescribed attendance may render me ineligible to appear in examinations or may result in such action as may be prescribed under the applicable rules.
20. That I shall conduct myself responsibly on social media platforms and in public forums and shall not publish, circulate or disseminate any material that is defamatory, obscene, abusive, misleading or otherwise prejudicial to the reputation, interests, discipline or functioning of the Institute.
21. That I undertake to clear all dues, charges, penalties, damages, fines or other amounts payable by me to the Institute before completion of the course or issuance of any certificate, diploma, transcript or other document. I understand that the Institute may withhold such documents until all dues are fully cleared.
22. That I shall join the internship centre, institution, organization or establishment allotted or assigned to me by the Institute and shall faithfully comply with all applicable rules, regulations, guidelines, instructions, terms and conditions governing such internship.
23. That any dispute arising out of or relating to this undertaking shall be subject to the jurisdiction of the courts and tribunals having jurisdiction over the Institute where I am admitted.

This clause shall apply only to women candidates

24. That I understand that the Diploma in Sports Coaching involves regular physical training, practical sessions, field activities and prescribed physical fitness requirements. In the event of pregnancy or any related medical condition arising during the course then I shall promptly inform the Institute and submit the requisite medical advice, reports and certificates issued by a registered medical practitioner. I further understand and agree that my continuation in, deferment of, suspension from or discontinuation of the course shall be subject to the medical advice so furnished and the applicable rules, regulations, policies and decisions of the Institute or of the Competent Authority and decision shall be binding upon me. I acknowledge that the Institute shall not be liable for any medical complications, injury, loss or consequences arising from my participation in physical training or course-related activities during pregnancy where such participation is undertaken contrary to medical advice or without disclosure of the pregnancy to the Institute.

I understand and agree that my candidature/admission may be cancelled, withdrawn or terminated at any stage of the course without any notice to me if I am found to have violated any provision of this undertaking or any rule, regulation, policy, direction, order, guideline or instruction issued by the Institute or any Competent Authority from time to time.

I hereby solemnly declare that the statements made hereinabove are true and correct to the best of my knowledge, information and belief and nothing material has been concealed or misrepresented therein. Standard Rules & Regulations for Hostel Accommodation For SAI, Academic Centres

1. All hostel residents shall maintain the highest standards of discipline, conduct, and behaviour expected of students of a premier national institution. They shall behave courteously and respectfully with fellow trainees, faculty, staff, visitors, and members of the public both within and outside the SAI campus.
2. Every resident shall carry his/her valid SAI Identity Card at all times and produce it whenever required by the competent authority.
3. All residents shall strictly adhere to the prescribed dress code and maintain decency in appearance and conduct.
4. Hostel rooms, common areas, toilets, dining areas, and surrounding premises shall be kept clean, hygienic, and free from litter. Pasting notices, writing on, or defacing hostel property is strictly prohibited.
5. Hostel rooms are allotted on personal responsibility. Residents shall ensure the proper upkeep of their rooms and hostel property. Any damage caused to the room or its contents shall be the responsibility of the occupant(s).
6. Any maintenance requirement relating to civil, electrical, plumbing, carpentry, sanitation, or other works shall be promptly reported to the Warden/Hostel In-charge.
7. Residents shall cooperate with hostel authorities during maintenance or repair works and shall temporarily vacate rooms whenever required. Alternate accommodation, wherever feasible, shall be arranged by the hostel administration.
8. Possession or storage of any illegal, pirated, obscene, or otherwise prohibited material in any form is strictly prohibited.
9. Any loss of or damage to hostel property shall be recovered from the responsible resident(s). Where responsibility cannot be fixed, the competent authority may recover the cost collectively from the concerned hostel residents based on the report of the Warden/Hostel In-charge.
10. Hostel furniture, fixtures, and fittings shall not be shifted, exchanged, removed, or altered without prior permission. Any unauthorized possession of hostel property shall attract penal charges as determined by the hostel administration.
11. Residents shall not remove fixtures or fittings from any room or common area for personal use.
12. Ragging, bullying, harassment, discrimination, or any form of physical, verbal, psychological, or sexual misconduct is strictly prohibited and shall invite disciplinary action in accordance with the directives of the Hon'ble Supreme Court of India, Government of India regulations, and SAI rules, including expulsion from the hostel and the course.
13. Every trainee shall immediately report any incident of ragging or harassment. Failure to report such incidents despite being a victim or witness may also invite disciplinary action.
14. Where individual offenders cannot be identified, collective disciplinary action may be imposed on the group, if considered appropriate by the competent authority.
15. The following are strictly prohibited within the hostel and SAI campus:

- Smoking or use of tobacco products.
- Consumption or possession of alcoholic beverages, narcotic drugs, or intoxicating substances.
- Gambling in any form.
- Intimidation, violence, fighting, or threatening behaviour.
- Wilful damage to hostel or institutional property.
- Entering the hostel or campus under the influence of alcohol or drugs.
- Unauthorized movement within the campus after the timings prescribed by the competent authority.
- Shouting, use of abusive language, or creating nuisance in the hostel or campus.
- Employing unauthorized persons for personal work.
- Cooking inside hostel rooms.
- Use or possession of prohibited electrical appliances such as immersion rods, electric kettles, heaters, induction cookers, electric irons, cooking gas cylinders, or any other appliance prohibited by SAI from time to time.
- Creating noise through loudspeakers or high-volume audio devices.
- Misuse of internet or IT facilities, wherever provided.
- Any other act of indiscipline considered inappropriate by the competent authority.

16. Room service is not permitted. However, sick diet may be provided in the room with prior approval of the Mess/Hostel In-charge.

17. Residents shall not participate in any anti-national, anti-social, unlawful, or undesirable activities within or outside the campus.

18. Any prohibited electrical appliance found in a hostel room shall be confiscated, and the resident shall be liable to a fine of **₹1,000** or such amount as may be prescribed by SAI from time to time.

19. Audio systems or other devices causing inconvenience to fellow residents shall not be used. Possession of objectionable or prohibited digital content is also prohibited.

20. Students shall not keep any two-wheeler or four-wheeler inside the hostel premises. Bicycles may be permitted subject to the approval of the hostel administration.

21. Residents shall switch off all electrical appliances, lights, fans, and water taps and lock their rooms whenever they leave. They shall be responsible for any loss or damage resulting from negligence.

22. Students shall not resort to strikes, demonstrations, boycotts, or any form of indiscipline to press personal or collective demands. Any such misconduct may result in disciplinary action, including expulsion from the hostel.

23. Residents intending to remain outside the hostel overnight or for one or more days shall obtain prior permission from the Warden/Hostel In-charge.

24. Every resident shall record his/her entry and exit in the prescribed In/Out Register maintained at the hostel gate and comply with any attendance or mess registration requirements prescribed by the hostel administration.

25. Hostel entry and exit timings shall be notified by the competent authority from time to time and shall be strictly observed.

26. Offering tips, gifts, or any other gratification to Wardens, Security Personnel, Housekeeping Staff, or any other hostel employee is strictly prohibited.

27. Residents shall comply with all instructions issued by the Warden, Hostel Administration, or competent authority from time to time in the interest of safety, security, discipline, and smooth functioning of the hostel.

Refund of Hostel Fee

1. Boarding and lodging charges once paid shall ordinarily be non-refundable after the trainee has occupied the hostel, except where otherwise permitted under the applicable SAI policy.
2. The Hostel Caution Money shall be refunded after successful completion of the course, subject to adjustment of any dues, damages, or recoveries.
3. A trainee expelled from the hostel on disciplinary grounds shall not be entitled to any refund of the boarding and lodging charges.
